- **1. Opening Reflection:** Jenny read a Meister Eckert quote "Enough." A comment from the <u>Contemplative Reader</u> Nov 21 "Only love changes us." Pat shared her 2nd meeting with Thomas at Lama offered an example of transforming anger into love.
- **2. Approval Minutes November 15**. November 15, 2022 Minutes were approved by consensus.
- 3. Updated Signers Statement officially approved:.

"In order to be compliant with best financial practices, the Governing Board of Contemplative Outreach, Ltd approves the following in regard to persons who have authority to sign checks for both our Lakeland Bank and First Bank accounts:

6. 2024 Conference Discussion:

These two members would then discern the next steps while communicating closely with their respective groups. - -Determining the advisability of hiring a coordinator.
